

2023 AFR Continuing Education Scholarship Application

Application Guidelines

1. Applicant or member of applicant's immediate family must be an AFR Insurance policyholder.
 - a. Member of policyholder household – eligible
 - b. At least one parent in split household is policyholder – eligible
 - c. Grandparents of applicant are policyholders and applicant is residing in grandparent's household – eligible
 - d. Other applicant policyholder situations are not eligible, unless granted by AFR Home Office in advance
2. Applicant must have received the 2022 Incoming Freshman Scholarship to be eligible for the 2023 Continuing Education Scholarship.
3. Applicant must have a minimum cumulative 3.0 Grade Point Average on a 4.0 Grade Scale. To receive the first half of the scholarship (fall semester), student must submit fall semester enrollment of 12 hours or more to the AFR Youth Coordinator. To receive the second half of the scholarship (spring semester), students must have: 1) earned a 3.0 GPA the preceding semester and 2) continued spring semester enrollment of 12 hours or more.
4. Upon receiving a scholarship award, the applicant must serve as a judge for one or more of the 2023 AFR Speech Contests and attend the 2024 AFR State Convention or a variation of the above activities pending approval from the AFR Youth Coordinator.
5. Applicant must have attended three or more AFR events throughout the year.
6. Applicant may also be asked to serve as a chaperone during the 2023 AFR Leadership Summit.
7. Applications must be accompanied by an official transcript, resume and digital headshot of the applicant must also be emailed to tailor.atkinson@afrmic.com.
8. Applications must be received to the State AFR Office by **April 3, 2023**.
9. AFR scholarships are directed only for undergraduate level studies, if funds are available. Any exceptions must be approved by AFR.
10. Any extenuating circumstance may be appealed to the AFR Home Office, Attn: Youth Coordinator, for review and final ruling in advance.
